Terms and Conditions for the sports classes in Hangar 646

General Information

1 – These Terms and Conditions are an extension of the General Terms and Conditions of Hangar 646. Every participant of the sports classes in Hangar 646 is obliged to follow the rules contained in the Terms and Conditions of Hangar 646, which are applicable on site.

2 – The organisation of the sports classes, happening in Hangar 646, is handled by Gravity Park Sp. z o.o. with its headquarter located in Warsaw at 35 Goplańska Street, 02-954 Warsaw, tel. 22 123 55 66 registered into The National Court register in The Register of Entrepreneurs under the number 0000514593, entered in The National Official Business Register, REGON under the number 147296989, tax identification number NIP 9512380720, hereinafter referred to as the Organiser.

3 – The person purchasing sports classes in Hangar 646, hereinafter referred to as the Customer, is obliged to read these Terms and Conditions.

4 – The person taking part in the sports classes is hereinafter referred to as the Participant.

Enrollment

5 – Making a payment for the sports classes is tantamount to accepting these Terms and Conditions.

6 – Confirmation of enrollment for sports classes takes place when the calculated amount is paid. The customer is notified about the payment date by email. Failure to meet the payment deadline results in removal from the list of the sports classes' participants without a guarantee of the possibility of re-enrolling if the place in the group is purchased by another Customer.

7 – Payment for the sports classes can be made via the website or on site at any Hangar 646.

8 – The participant can sign up for a single trial class or for all classes in a given group in the current calendar month.

 9 - By enrolling a Participant for sports classes, the Customer acknowledges that they are reserving and paying for a place in a specific group at a specific date, from the date of enrollment to the end of the paid month The amount for paid classes is non refundable.

10 - In case of not collecting the minimum number of participants amounting to:
a) 4 people in a group of 4 - 6 people

b) 7 people in a group of 7 - 10 people

c) 14 people in a group of 14 - 30 people the organiser reserves the right to cancel classes or to dissolve the group.

11 - Hangar 646 reserves the right to change the schedule of classes (cancellation of individual classes) or to the dissolution of the groups with less than a minimum number of participants.
If such a change occurs during the ongoing semester, the difference in price resulting from the remaining paid classes will be refunded.

12 – The organiser provides trained staff of instructors and trainers for the duration of the classes. In the absence of the instructor, the organiser provides a substantial replacement. In the event that it is not possible to find a suitable replacement, the organiser reserves the right to cancel individual classes and reimburse or postpone the cost of the cancelled classes to the next month of classes.

Reporting and Making up for absences

13 – Reporting an absence is possible only through the client zone of the ActiveNow portal, before the start of the classes. Failure to report the absence before the scheduled date is tantamount to losing the possibility to make up for said classes.

14 – The participant has the possibility to make up for classes in any Hangar 646 and in any group, provided that the group is in the Participant's dedicated age range and at the appropriate level of advancement.

15 – Making up for absences is possible in groups where the maximum number of participants is not met.

16 – It is possible to make up for the classes until the end of the current class semester / paid classes in a given semester.

17 – If the Participant is not able to make up for the reported absence, they can exchange it for a voucher for a single entry to any Hangar 646. The value of the voucher is the same as the price of the group ticket to the Hangar and amounts to PLN 24.

18 – Accepting the make-up date is tantamount to making up for the absence - the agreed date is final.

19 – The Organiser does not reimburse the costs for the sports classes which the Participant did not attend, regardless of the reason for the absence.

Terms and Conditions for the sports classes in Hangar 646

Age limitations

20 – The classes may be attended by children from the age 3, adolescents and adults.

21 – Participants may sign up for classes only in the dedicated age group. In exceptional circumstances, the Organiser reserves the right to individually assign a Participant to the age group.

22 – Each Participant of the sports classes must be registered in the system before the start of the first class. Registration can be made on the website www.hangar646.pl in the "Registration" tab or at the location.

23 – The guardians of children or the guardian of a group under 11 years of age should be present on the premises of the facility during the sports classes.

Liability

24 - Hangar 646 instructors / trainers are responsible for the safety of participants during the classes, which means that:
a) the trainer is in the hall during the classes;
b) the trainer has the right to leave the place of the classes only when the group is under the supervision of another trainer.

25 – Instructors are not responsible for the participant's unauthorised leaving the classes and departure from the classes.

26 – Hangar 646's trainers do notprovide care over the participants of the classes, understood as care of meeting the needs of a person. Trainers / instructors are required to conduct the classes as described and to look out for the safety of participants during the classes.

27 – A guardian of a child who is under the age of 6 should be present in the sports infrastructure during the sports classes in order to care for them.

28 – The guardian of the participant is responsible for the safety of children in the changing rooms and on the premises of Hangar 646.

29 – The Participant should arrive on time in sports clothes and in non-slip socks. Being late for sports classes results in a shortening of the warm-up time or the Participant can be ordered to do the warm-up on their own.

30 – Before the start of the classes, the Participant should immediately inform the trainer

about any possible injury or health problems that may prevent them from doing certain exercises.

31 – First aid in Hangars 646 is provided by a trainer. If necessary, an ambulance is called.

32 – The Participant is obliged to follow the safety rules of Hangar 646 and to avoid situations that can be threatening to their own safety and that of other participants of the classes.

33 – A Participant of the sports classes, who does not follow the Terms and Conditions of Hangar
 646, can be removed from the list of participants without the possibility of reimbursement

Access to the ActiveNow portal

34 – Enrolling for sports classes is carried out through the ActiveNow web portal or in any Hangar 646.

35 – Providing data such as: name and surname of the Customer and the Participant, date of birth of the Participant, telephone number and e-mail address of the Customer is necessary to provide the service, and refusal to provide them results in removal from the list of participants. Full use of the ActiveNow function is possible only after entering the data above.

36 – By providing their personal data, the customer, who books a place in a group, agrees to processing said data for the purpose of enrolling for sports classes.

37 – At any moment The Participant has the right to access, change and delete their personal data at the time of resignation from the classes.

38 – The data processed by the organiser may be entrusted to persons responsible for IT support of Hangar 646, but only for the purposes necessary for its operation.

39 – By accepting the Terms and Conditions above, the consent to the processing, updating, sharing and storage of personal data of the Participant and of the Customer, is given for the purposes of the proper conduction of the sports classes.
